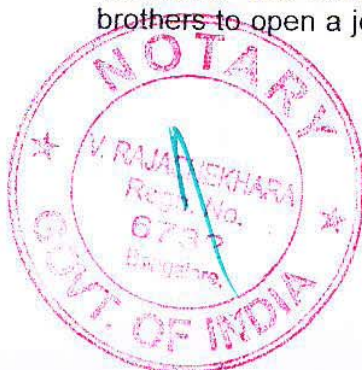

Gentlemen:

Under instructions from our client Sri. Mohammed Iqbal Lodhia residing at 675 Fifteen Mile Drive, Roseville, California, 95678 United States of America, we issue this notice as under:

1. Our client states that the first of you is engaged in the business of constructions in Bangalore, India and second of you is the proprietor/partner of the first of you. Our client states that his father Mr. Noor Mohammed Lodhia, who was a resident of the State of New York, United States of America developed acquaintances with you during his visits to India and on account of the said relationship and acting on your representations and promises of better returns, he made several investments in properties in Bangalore through you.

Our client states that his father Mr. Noor Mohammed Lodhia died on April 29th, 1998 leaving behind our client, his wife Fatima (now deceased), his daughter Mehroon Nisa Lodhia, and his sons Mr. Mohammed Yousuf Lodhia, Mr. Razzaq A. Lodhia and Mr. Mohammed Rafiq Lodhia as his legal heirs. Thereafter, the brother of our client, Mr. Mohammed Yousuf Lodhia, was appointed as the administrator to the estate of the Late Noor Mohammed Lodhia by the Surrogate's Court of the State of New York, Queens County.

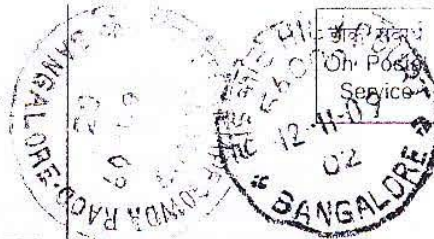

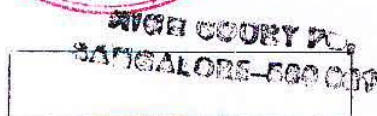
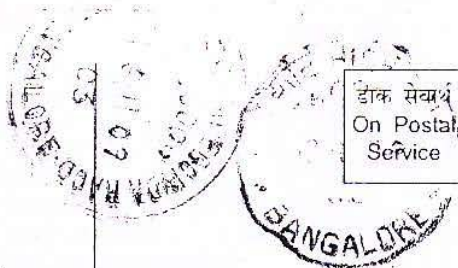
